The following items will **NOT** be accepted:

Any items containing freon, gas, oil or antifreeze Engine or mechanical parts containing gas, oil or antifreeze No liquid paint, no paint cans, no hazardous liquids No tires or batteries No yard waste, lawn clippings, tree branches or brush No electronics, computers or printers, TV's, VCR's, DVD

players, radios, or game systems No telephones, microwave ovens or other appliances The above items should **not** be placed in a landfill.

Household Hazardous Waste (HHW) recycling will be done through the Charlevoix County Recycling Program. The dates for the 2020 spring HHW recycling event have been set for June 12 and 13, 2020.

FROM THE TREASURER'S DESK

Office Hours

Monday thru Friday, other than holidays. 8:00 to 5:00, with limited availability on Saturdays. Messages and emails are returned within 24 hours. This is an in home office, so if you prefer to pay your taxes in person, you may do so by calling in advance. On the last day of each tax collection, September 14 for summer and February 14 for winter, office hours are held at the Township Hall from 9:30 to 4:30. In case the date falls on a holiday or weekend, the date will be the next business day. Office hours are also held one day during the last week of the year. The date and hours are reflected on the winter tax bill.

Winter 2019 Taxes are due on or before February 14, 2020. Penalty and interest, as noted on the tax bill, apply after that date.
U.S. postmark is accepted. Note, after March 2, 2020, Taxes due must be paid through the County. Contact the County Treasurer's office at 231-547-7202 for amount due.

Tax Exemptions Available:

Disabled Veterans, full exemption for property owners who are veterans of the armed forces, were honorably discharged and and have a 100% diablility. Unmarried surviving spouses are also eligible.

Low Income Homeowners: homeowners with low income, subject to federal poverty levels and asset levels, may be eligible for an exemption from property taxes. Applies to principal residence only. Both exemptions require an annual application to be filed with the Township Assessor. Contact your Township Treasurer for qualification and application details.

Address changes and corrections are Important toward assuring that your tax bills and other correspondence are received promptly. A change will be processed in the Township and County Equalization records by submitting a change request in writing directly to the Township Treasurer.

Questions raised after tax bills are issued, such as property valuation or Homestead/PRE status, are handled at either a July or December Board of Review held at the Township Hall. Such changes may result in a change to your tax bill and will be processed within a week of the Board of Review. If the Board of Review results in a change to the prior year, corrections will be processed by the County.

Mortgage Escrows:

Tax information is forwarded to your Bank or Mortgage Company upon their request. Please

note that many Companies process a check for Escrow Payments through a third party Service Agency and accordingly your Company's check date is earlier than when I am mailed the check.

Summer bills mailed on or before July 1, 2020 and due on or before September 14, 2020. Winter bills mailed on or before December 1, 2020 and due on or before February 15, 2021.

SHORT TERM RENTAL

Can a residential property owner in the township retain their principal residence property tax exemption if the owner rents the property for short-term rental purposes over the summer?

Pursuant to the Michigan Department of Treasury, the owner may not rent out their property for more than 14 days a year and retain the principal residence property tax exemption. Rental of the property for less than 15 days a year would entitle the owner to keep the principal residence exemption. In reaching this opinion, Treasury points to federal law that requires a residential property owner to declare the property as "rental property" on their tax return if they rent the residence out for more than 14 days a year.

A rental property is a commercially used property and cannot qualify for a principal residence exemption under Michigan law. An existing exemption would be rescinded as of December 31 of the year it is used as rental. property.

2020 Election Information

Absent voter applications for those on the permanent absentee voter list will be mailed approximately six weeks prior to each election. If you would like to be added to the permanent absentee list please contact me.

A ballot will be mailed following receipt of the absentee voter application. Please indicate on the application the address the ballot should be mailed to if that address is different from the address where the application was received. It is helpful if the date you will be leaving Eveline Township is indicated on the application.

OFFICAL BALLOTS CANNOT BE FORWARDED.

Please keep in mind mailing time is 2 to 7 days depending on where items are being sent to and from.

Please be sure to sign and date both the application and the return ballot envelope. An unsigned ballot cannot be submitted to election workers for counting.

I will be at the Township Hall from 8:00 a.m. – 2:00 p.m. the Saturday before each election and from 9:00 a.m. - 4:00 p.m. on the Monday before each election.

It's time to get REAL

A message from Secretary of State Jocelyn Benson

Your Michigan driver's license or identification card may not get you through airport security later this year.

Oct. 1 is when the federal government will fully enforce the post-9/11 REAL ID Act, and standard state-issued driver's licenses and identification cards will no longer be accepted to board domestic flights within the United States, or when entering certain federal facilities, such as military bases or nuclear power plants.

Many people already have a REAL ID document, such as a valid U.S. passport, a DHS Trusted Traveler Card or an Enhanced Driver's License. A full list of acceptable REAL ID documents is available at TSA.gov. Those who don't can make their Michigan license or identification REAL ID-compliant by visiting a Secretary of State branch office and presenting the required documents. And, if you make an appointment, you'll be in and out in 30 minutes or less.

Here's what you need to do to get a REAL ID:

- To schedule an appointment at one of our branch offices visit Michigan.gov/SOSAppointments or calling 888-SOS-MICH. You can make your appointment at any branch in the state, and you don't need to have a renewal mailer to do so. Some branches fill up fast, so book your appointment a few weeks in advance of when plan to travel. Your REAL ID license or state ID card will be mailed to you.
- Bring your driver's license or state identification card.
- Bring your certified birth certificate, with a raised seal or stamp issued by a governmental agency; your valid, unexpired U.S. passport; or an approved citizenship or legal presence document. (Faxes and photocopies won't be accepted.)
- If your name differs from what is on your birth certificate, bring certified documents for every time your name has changed, such as marriage licenses or court orders.

There's no additional fee to turn a license or state ID card into a standard REAL ID if it's done during your normal renewal time; otherwise a duplicate card fee of \$9 or \$10 will be charged.
